Professor Peter Vail had a very unfortunate accident recently and will probably be in hospital for a considerable time. We were looking forward to his talk about sequence stratigraphy, scheduled for June 23. Obviously he will be in no position to come. We wish him well and hope he will recover fully.

Therefore the PGK greatly appreciates that Drs. P.F.M. de Groot from TNO Institute of Applied Geoscience, offered, at such short notice, to speak about: 'Reservoir characterisation from 3-D seismic data using artificial neuronetworks and stochastic modelling techniques'. This very modern approach to seismic interpretation guarantees an extremely interesting lecture, which many members will undoubtedly wish to attend.

The speaker has submitted the following abstract:

For an accurate prediction of the production profile of a hydrocarbon reservoir an optimum assessment of the geological reservoir model is required. The reservoir architecture and lithostratigraphic properties of the model are most important boundary conditions in the economic evaluation of the reservoir. Integration of data from different sources with widely varying resolutions and accuracies is a prerequisite to achieve this objective.

The presentation will show how artificial neuronetworks and stochastic modelling techniques are used to combine different sources of geo-information in reservoir characterisation.
