Schoonebeek drilling 2009-2011: design, operations and results of 73 redevelopment wells

#### **Abstract**

Schoonebeek is one of the biggest oil fields in Western Europe, with >1billion barrels originally in place. The Bentheim Sandstone reservoir (Lower Cretaceous) is between 10 and 40m thick. The field was closed in in 1996, and the nearly 600 wells were mostly abandoned. From 2001 onwards, redevelopment concepts were studied, resulting in a proposal to drill 44 horizontal production wells, 25 horizontal steam injection wells, and 4 observation wells. High-resolution 3D-seismic was acquired in 2005, the final go-ahead was given in 2007, and from early 2009 onwards there was a period of 2 1/2 years of continuous drilling with one or two rigs.

Today's presenter was the senior geologist for the project during final well design and drilling operations. He will describe how the wells were designed, what were the main challenges, and what happened in reality. In the end, over 100 km of wellbore were drilled. Most wells were placed close to plan, and 40 young graduates had an interesting 5-month work experience as wellsite petroleum engineers. In the meantime, the field is producing and the geologists have moved on.
